Consignment Agreement

Agreement made, effective as of Date: _____

Subsequently referred to as "owner" or consignor, and Power Business Store, subsequently referred to as "dealer" or consignee.

In consideration of the mutual obligation and undertaking hereinafter set forth, owner and dealer hereby covenant and agree as follows:

1. Dealer shall have the exclusive right to sell and distribute owner's goods via an internet auction site during the term of this agreement.
2. Dealer agrees to take possession of goods, making a listing of such goods in a CUSTOMER'S ITEM DETAIL FORM, sign and date this CUSTOMER'S ITEM DETAIL FORM, and return a copy with owner at the time when the goods are delivered to dealer.
3. Dealer agrees that the goods for which it is granted the exclusive right to sell are limited to those goods set forth in CUSTOMER'S ITEM DETAIL FORM, which attachment is incorporated in the agreement by this reference.
4. Owner shall deliver the dealer its goods for sale.
5. Dealer shall be responsible for any loss of or damage to said goods while it is under his control.
6. Dealer agrees to photograph all items and list them on an internet web site within two weeks of receipt of goods.
7. Owner agrees to pay all fees imposed by EBay and PayPal, amounts to be deducted from owner's commission.
8. Starting bidding prices for auction are \$ 9.99 with no reserve.
9. Owner agrees that if they wish to increase the stating price beyond \$9.99, or if they want a reserve price placed on the item, they will pay the additional listing fees out of the owner's percentage of the final sale price.
10. Owner agrees that id they (the Owner) bid on their own item, that this agreement is null and void, this auction will be terminated, and the item will be return to the Owner.
11. The URL for the listing auction will be emailed to the owners so that the owner can monitor the progress of the auction.
12. At the end of the auction, if there is a winner bid, and after the winning auction bidder receives the item and is satisfied, dealer will then write out a check to the owner for their percentage as set forth herein, and mail it to owners at the above address along with a copy of the auction documentation.
13. Owner agrees that if the goods are sold, dealer's commission on those sales are set forth according to the following schedules:

35% of the first \$200.00

30% of the next \$300.00

25% of the next \$500.00

20% of the next \$2000.00
15% if the remaining amount over \$3000.00

14. Auction WILL NOT is cancelled once a legitimate bid has been received. All auctions are final upon close of bidding.
15. Dealer shall devote his best efforts to the sale of owner's goods via internet auctions; however, Dealer makes no guarantees as to the final sale price due to the bidding nature of on-line auctions.
16. Consigned merchandise shall remain the property of the owners until sold, however, if the item does not sell, dealer will contact owner and discuss available options. And the owner will have to pay the seller the listing fees for auction.
17. Owner warrants that he or she is the legal sole owner of the property to be sold. Owner further warrants the description of the item is true and correct ad far as he or she knows. The owners also attests that said item (s) are fully owned by the owner and are not stolen, borrowed, misrepresented, bogus, etc.
18. Any modification of the agreement or additional obligations assumed by either party in connection with this agreement shall be binding only if evidenced in a writing signed by each party.
19. This agreement is not assignable.
20. This agreement shall constitute the entire agreement between the parties. Any prior understanding or representation of any kind preceding the date of this agreement shall not be binding on either party except to the extent expressly set forth in this agreement.
